SPEAKER HIGHLIGHTS



Tā Tipene O'Regan – Keynote Speaker

Tā Tipene O'Regan is best known for his role as Chairman of the Ngāi Tahu Māori Trust Board which he guided to successful land and sea fisheries claims before the Waitangi Tribunal, culminating in the Tribunal's reports of 1991 and 1992. He later led claim settlement negotiations leading to the 1998 settlement, which made extensive provision for customary rights in fisheries and other natural resources. Tā Tipene has been Chairman and director of public and private sector entities and has held major board appointments in both the heritage and environment sectors. In more recent years, Tā Tipene has become a widely recognised participant in the discussion on the need for a "New Zealand constitution", the shape of the Māori economy and modernising iwi governance models.



Tā Mark Solomon – Keynote Speaker

Ngāi Tahu, Ngāti Kuri

Tā Mark initially worked as a foundry metal worker before being elected as the representative of Te Rūnanga of Kaikōura in 1995 - A role that enabled him to be elected as the Kaiwhakahaere of Te Rūnanga o Ngāi Tahu where he went on to lead Ngāi Tahu post-treaty settlement for 18 years. In 2005, Tā Mark helped establish the Iwi Chairs Forum and was an original member of the Minister for Māori Affairs, Māori Economic Development Taskforce. Tā Mark then went on to play a key role in re-establishing the Māori trades training initiative, 'He Toki ki Te Tika' in 2011. Tā Mark was named Visionary Leader of 2012 in the Deloitte and New Zealand Management magazine National Business Awards and was recognised in the Queen's New Year Honour as a Knight Companion of the New Zealand Order of Merit for services to Māori and Business. In 2016, Tā Mark was awarded the Kea World Class New Zealand Award, and is a champion for Tū Pono: Te Mana Kaha o Te Whānau, a pilot programme to explore ways of enabling stronger Māori responses to family harm and violence.



Naomi Aporo (MC)

Naomi has been involved in Ngā Kaitata Māori o Aotearoa since 2008. She is passionate about advancing Māori economic development in ways that maintain our values and authenticity. Over the last ten years Naomi has had a broad and varying career. Starting in business risk and performance improvement at EY, she has since worked for Te Wānanga o Aotearoa, Fonterra and most recently Wakatū Incorporation. Naomi's experience is in strategy design, operational modelling, organisational design and development, and programme management. She also currently serves on the kahui for the NZ Land and Water Science Challenge.



Hon Nanaia Mahuta

*Minister for Māori Development and Local Government
Associate Minister for the Environment*

As a mother, and a constituent MP with 20 plus years' experience who has come from 'flax-root' politics, Hon Nanaia Mahuta remains connected to the aspirations of people from all walks of life. Those who work hard for a living so that their children can do better, kaumatua, trades-people, those who aspire to own their home, those who own small businesses and those who lead a range of services and organisations and huge iwi entities.

During her time in Parliament, Hon Nanaia Mahuta supported policies and initiatives that built the capacity of communities, especially social service organisations, greater investment in education, employment and training opportunities particularly for young people, supported the continuation of the Treaty Settlement process and supported specific initiatives that lift the wellbeing and opportunities for young mums and those who are vulnerable and victims of abuse.

Hon Nanaia Mahuta is a tribal member of Waikato-Tainui, Ngāti Maniapoto and Ngāti Hine and her parliamentary experience has enabled her to contribute to the collective aspirations of Maori and all New Zealanders



Nathan Penny, Senior Rural Economist - ASB

Nathan Penny joined ASB as its Rural Economist in 2013, having previously worked at Westpac and the New Zealand Treasury.

Nathan hails from the Kapiti Coast and made the short trip up the road to study at Massey University where he graduated with a Master of Applied Economics. Nathan also lived and worked in Japan and he is a fluent Japanese speaker.

His expertise lies in dairy and other commodity markets, trade economics and economic forecasting. He authors ASB's monthly rural publication, Farmshed Economics. He's also a leading GlobalDairyTrade auction commentator, and is consistently the most-quoted bank rural economist in all forms of media.

Ngāi Tahu, Waikato Tainui

Kauahi is the General Manager of Whale Watch Kaikōura – one of New Zealand's leading and most recognised Māori tourism experiences.

Kauahi was first employed by Whale Watch as a 15-year old. He has moved through the ranks from his entry role as a caregiver (sea sickness bucket emptier), rising to learn all facets of the business from guide, guide trainer, skipper, skipper trainer, supervisor, frontline manager and chief operating officer. Kauahi is also a member of the Ministerial Advisory Committee for the Kaikōura Marine Guardians, a panel member of the Government's Tourism Infrastructure Fund, a Director of Tourism Industry Aotearoa, and was named the 2018 Outstanding Māori Business Leader at the University of Auckland Aotearoa Māori Business Leaders Awards.



Andrew Trevelyan, General Manager Communication and Engagement –Ōtākaro Limited

Andrew is the General Manager Communication and Engagement for Ōtākaro Limited – a company established to deliver Crown-led Anchor Projects in Central Christchurch. Andrew has more than 30 years' experience in business communication, having held management roles at private and public organisations such as Tait Electronics and Landcare Research. When 80% of central Christchurch buildings had to be demolished after the disastrous 2011 earthquakes, the opportunity arose to recreate a CBD that was a more attractive place to work and live in, and visit.

Helen Leahy is the Chief Executive of Te Pūtahitanga o Te Waipounamu (Whānau Ora Commissioning Agency) an entity whose vision is ensuring whanau are able to fulfil their dreams and aspirations, are culturally connected, thriving contributing members of their communities. She has held several senior roles in Parliament including Chief of Staff of the Māori Party and Senior Ministerial Adviser for the former Minister for Whānau Ora. Sacha McMeeking

Sacha is currently Head of School - Aotahi and Māui Lab Co-Director at Canterbury University. She brings a serial entrepreneur's approach to working with and for Iwi Māori. From instigating United Nations proceedings to architecting a Māori social enterprise fund and leading commercial negotiations, she is known for solution-building that meets Iwi Māori aspirations. Previously Sacha was the director of a boutique consultancy working with Iwi Māori in strategy development, kaupapa Māori asset management and innovation and the General Manager Strategy and influence with Te Rūnanga o Ngāi Tahu, responsible for government relations on behalf of the Iwi.

Andrew Priest

Andrew is the Chief Executive of Ngāi Tahu farms after joining in July 2015. Previously he led his own consulting practice across a range of industries with an emphasis on strategy, performance improvement, risk management, and organisational alignment. He oversees a diverse farming business that includes dairy, sheep and beef and forestry, recognising the significant challenge for both Ngāi Tahu and New Zealand in offsetting its environmental footprint globally.

Melanie Mark-Shadbolt

Melanie is an Indigenous environmental sociologist and Māori Research Manager. She is also the Māori Manager for New Zealand's Biological Heritage National Science Challenge, a founding member of Te Tira Whakamātaki; the Māori Biosecurity Network and has been a project leader and researcher in a number of National Science Challenge, Tertiary Education Commission and Ministry of Business, Innovation and Employment programmes including 'Mātauranga Māori characterisation of NZ's biodiversity,' 'Protecting NZ's primary sector from plant pests: a toolkit for the urban battlefield,' and 'Protecting New Zealand from extreme fire.'

Mananui Ramsden

Mananui is a Cultural Land Management Advisor for Environment Canterbury. After returning from Western Australia where he was working in mining and construction, Mananui has dedicated the next phase of his career to supporting the ecological wellbeing of Te Waihora. There are about 150 properties in the lake zone and another 200 within 20 metres of several waterways that collectively effect the wellbeing of the lake. Mananui works with farmers within the Cultural Landscape Values Management Area to achieve mahinga kai targets (including species, natural habitats, materials traditionally used for harvesting food and places where food or resources are gathered) in their farm environment plans.
